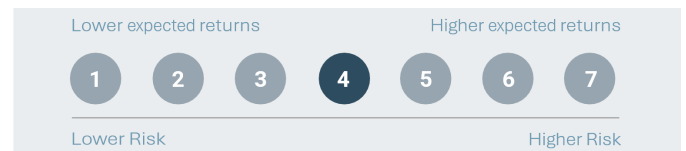

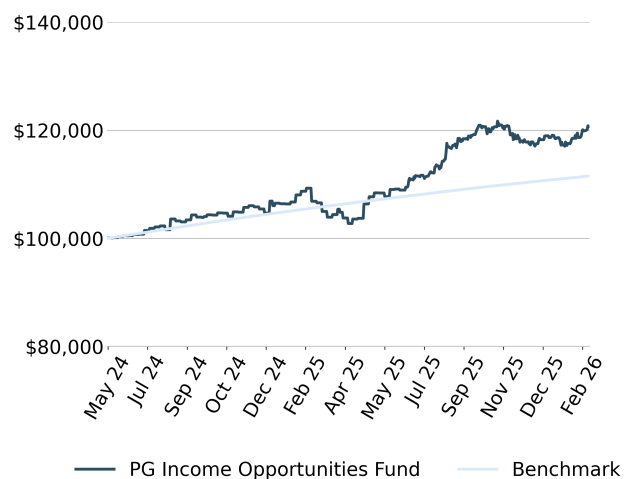
## Fund Description

It primarily invests in select equities that typically offer strong dividend yields, along with fixed interest securities and cash. This approach provides diversification across investment types and income sources, giving investors the potential for regular distributions.
