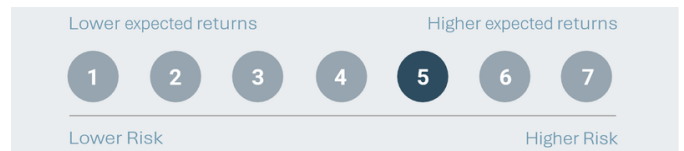

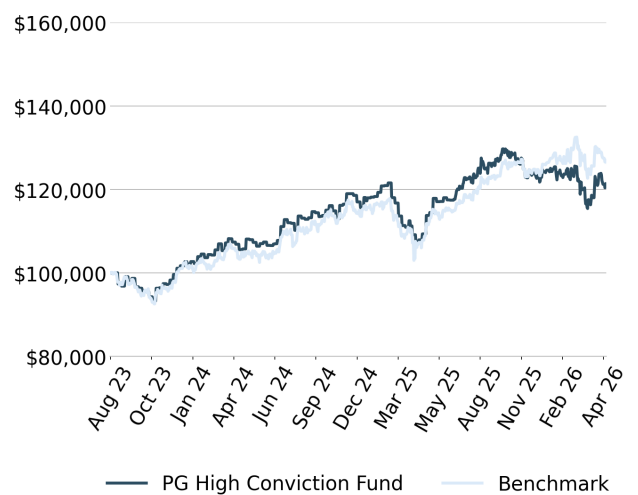
## Fund Description

The fund's main objective is to achieve long-term capital growth by investing in a select group of New Zealand and Australian equities. This approach allows it to navigate market ups and downs while aiming for sustained growth over the long run.

## Investment Strategy

The fund follows an active management approach, investing in a select group of around 10 to 30 companies listed in Australia and New Zealand. This focus supports deliberate selection and management of investments, rather than tracking an index. While the fund is centred on Australasian markets, it can invest in shares listed outside the region when appropriate. It is generally expected to remain fully invested, although it may hold cash or cash equivalents at times to manage risk and maintain flexibility. Its primary objective is to achieve long-term capital growth.
