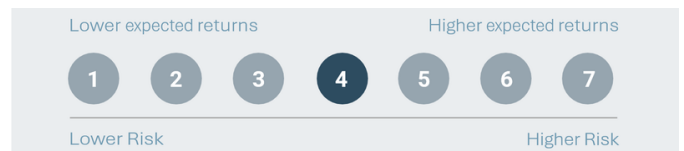

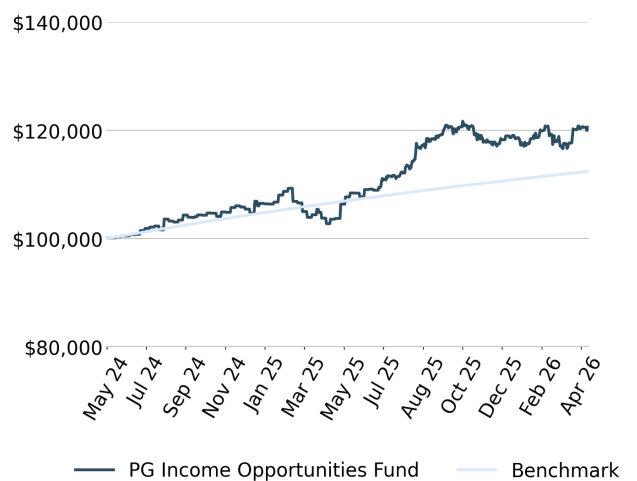
Fund Description

The fund aims to deliver a higher level of income from a diversified portfolio of equity and fixed income investments, while also providing moderate long-term capital growth.

Investment Strategy

The fund blends quantitative analysis with qualitative, fundamental research across Australasian investments. It primarily invests in select equities that typically offer strong dividend yields, along with fixed interest securities and cash. This approach provides diversification across investment types and income sources, giving investors the potential for regular distributions.
