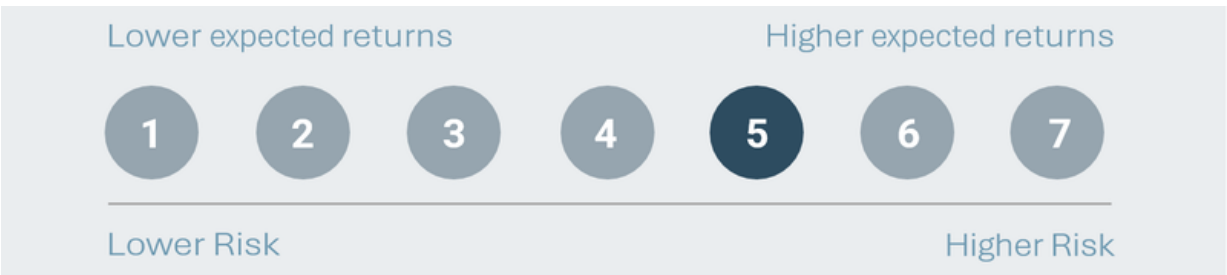
DESCRIPTION OF THE FUND

The fund aims to achieve long-term capital growth by primarily investing in international equities, including exchange-traded funds (ETFs) listed globally.

WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the PG Strategic Growth Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

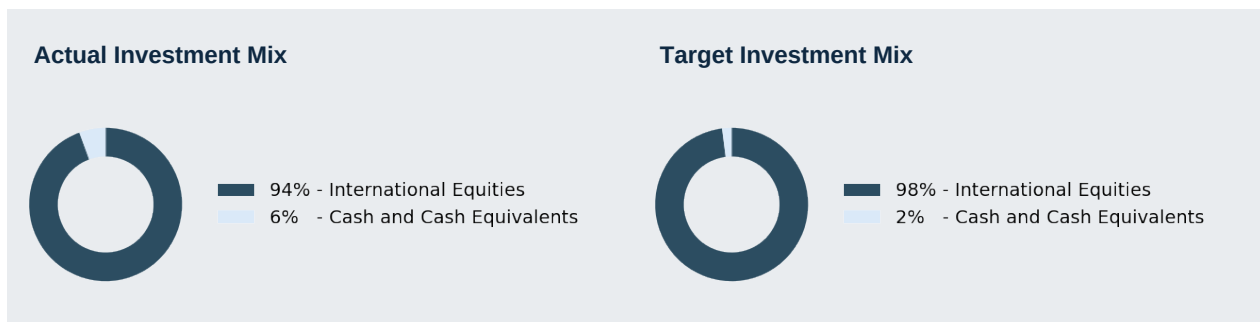
EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Tim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tim received a return after fund charges were deducted of \$1,941 (that is 19.41% of his initial \$10,000). Tim did not have to pay other charges. This gives Tim a total return after tax of \$1,844 for the year.
