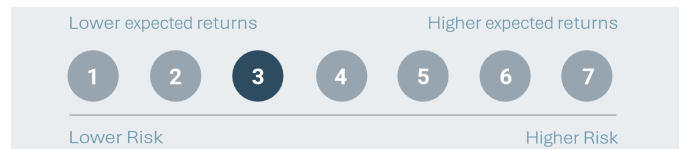

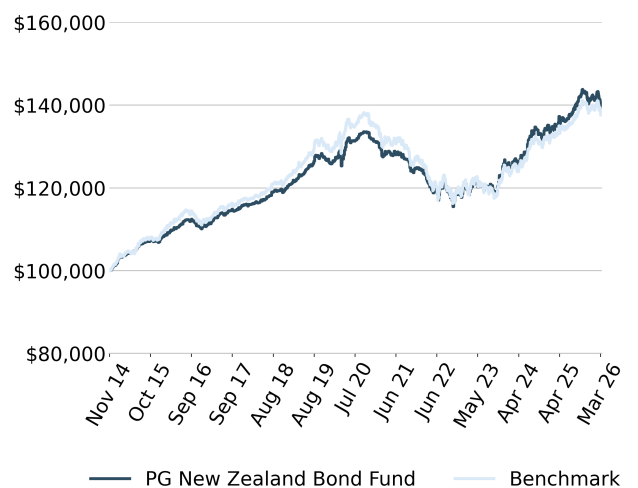
Fund Description

The fund is designed to provide regular income primarily from New Zealand investment-grade corporate bonds.

Investment Strategy

The fund primarily invests in select New Zealand corporate fixed interest securities. It uses active duration management, adjusting the portfolio's sensitivity to interest rate changes based on market conditions and economic outlooks. This approach allows for tactical positioning in response to expected interest rate movements, potentially enhancing returns and reducing risks from bond price fluctuations.
