## WHAT IS THE PURPOSE OF THIS UPDATE?

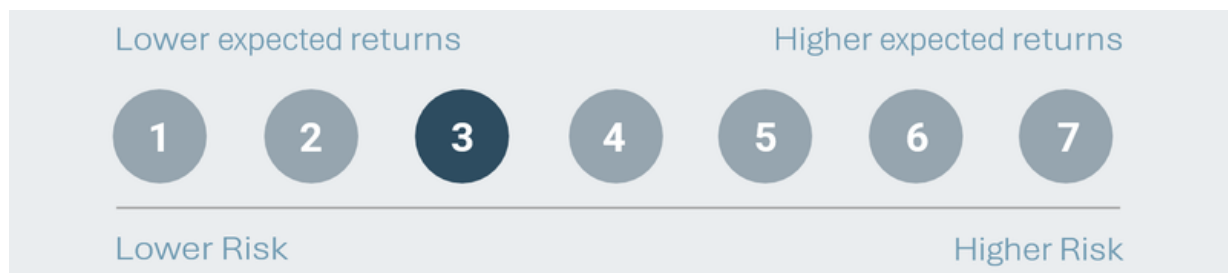
## DESCRIPTION OF THE FUND

## WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the PG New Zealand Bond Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

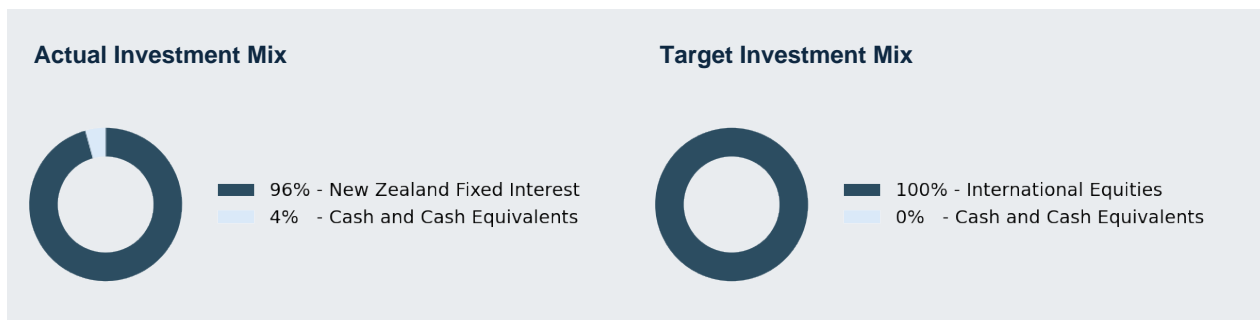
## EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Tim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tim incurred a loss after fund charges were deducted of \$-8 (that is -0.08% of his initial \$10,000). Tim did not have to pay other charges. This gives Tim a total loss after tax of \$-5 for the year.
